

H PUBLIC MEETING / PUBLIC HEARING NOTICES AND ADVERTISEMENTS

As part of the public involvement program, DDOT conducted two public information meetings and a formal public hearing to inform as well as solicit input from the general public on the proposed project during the initial EA effort. Numerous methods were employed to publicize the public meetings and hearing, including newspaper advertisements in The Current Newspapers and El Tiempo Latino Newspaper as well as announcements on both the project website and DDOT website. Postings were also made to the surrounding communities' and Advisory Neighborhood Commission's (ANC) listservs and announcements were mailed to adjacent property owners. These same notices were used to advertise the availability of the Environmental Assessment. The two public meetings and one public hearing were conducted on the dates listed below. Immediately after FHWA approved the Revised Draft EA for public review on October 15, 2020, DDOT conducted a virtual public involvement process via the project website in order to reduce the risk for COVID-19 (as defined by the Center for Disease Control) and in alignment with Mayor Bowser's current Coronavirus Phase Two Guidance at the time of publication. Announcements of the availability of the Revised Draft EA were emailed to all individuals and special interest groups who requested to be on the project mailing list throughout the project (n=386), and availability letters were also individually mailed to agencies, elected officials, utility representatives, and other project stakeholders (n=55).
