



## Speed Limit and Safety Nexus Studies for Automated Enforcement Locations in the District of Columbia 2600 Block Military Rd NW

Study Area and Location

District	PSA	Ward	ANC	Phase	Description

The *proposed* speed camera will be located in Ward 3 at the 2600 block of Military Road Northwest in the westbound direction. Military Road runs between 13<sup>th</sup> Street Northwest to the east and Western Avenue Northwest to the west. The posted speed limit is 35 MPH.





### Field Assessment Summary

Military Road is assumed to run in an east-west direction, and is classified as a principal arterial. Military Road has two travel lanes in each direction and left turn lanes at Oregon Avenue Northwest and 27<sup>th</sup> Street Northwest. This site has the following characteristics:

- There is one school in the area: St. John's College High School.
- The Rock Creek Park Nature Center and Planetarium and the Western Ridge Trail are in the area.
- There is a grassy median and sidewalk on both sides of the street.
- There are traffic signals with pedestrian signals with crosswalks at Oregon Avenue and Utah Avenue.
- The pavement is in good condition and there is curb and gutter with drainage inlets. There is a downgrade slope westbound.
- There are two bus stops westbound.







### Speed Data Analysis


The mean speed was 7 MPH lower than the posted speed limit and the 85<sup>th</sup> percentile speed was the same as the posted speed limit at this location.

### Crash Data Analysis

From the Accident Summary Report provided for the dates between January 1, 2010 and December 31, 2012, there were a total of 16 crashes at this location. A breakdown of collision type can be found in the chart on the next page. The most common type of collision at this location was Rear End with eight crashes. The other collision types had four crashes or less. Furthermore, this site experienced seven injury-related crashes.

### Safety Nexus

This site presents the following safety considerations which may establish a nexus between traffic safety and the speed camera:

- 1. Speed Data The speed data analysis shows travel speeds being lower than or the same as the posted speed limit.
- 2. Crash Data This location experienced seven injury-related crashes.
- 3. Field Assessment The following site characteristics suggest a need for a safer travel environment:
  - a. There is one school in the area, St. John's College High School.
  - b. The Rock Creek Park Nature Center and Planetarium and the Western Ridge Trail are in the area which generate pedestrian and bicycle activity.
  - c. There are several bus stops in the area which generate pedestrian activity.

Although the speed data analysis showed travel speeds being lower than or equal to the posted speed limit, at this location, there were a number of injury-related crashes at this location. Residents are concerned that

there is speeding on Military Road in this area. Due to the number of injury-related crashes, the specific site characteristics of a residential area, and the proximity to schools, parks and recreational areas, and the pedestrian generators, there is a nexus between traffic safety and the speed camera at this location
