



Speed Limit and Safety Nexus Studies for Automated Enforcement Locations in the District of Columbia 33rd Street at Northampton Street NW

Study Area and Location

The *proposed* speed camera will be located in Ward 3 at the intersection of 33rd Street and Northampton Street Northwest. 33rd Street Northwest runs between Pinehurst Circle Northwest to the north and Broad Branch Road Northwest to the south. The posted speed limit is 25 MPH.

Field Assessment Summary

33rd Street is assumed to run in a north-south direction, and is classified as a local road. 33rd Street and Northampton Street both have one travel lane each direction. Neither 33rd Street nor Northampton Street has centerline pavement markings. This site has the following characteristics:

- This is a residential area with houses.
- There is one school in the area: Lafayette Elementary School.
- The Lafayette Recreation Center is also in the area.
- This intersection is a four-way stop with crosswalks on all four legs.
- There is sidewalk an on-street parking on both sides of all four legs.

Speed Data Analysis

The mean speed is lower than the posted speed limit by 10 MPH in the northbound direction and 11 MPH in the southbound direction. The 85th percentile speed is lower than the posted speed by 5 MPH in the northbound direction and 6 MPH in the southbound direction at this location.

Crash Data Analysis

There have been no crashes reported at this location in the past three years (2010-2012).



Safety Nexus

This site presents the following safety considerations which may establish a nexus between traffic safety and the speed camera:

- 1. Speed Data The speed data analysis shows travel speeds being lower than the posted speed limit.
- 2. Crash Data The crash data analysis shows no recent crashes at this location.
- 3. Field Assessment The following site characteristics suggest a need for a safer travel environment:
 - a. This site is located within a residential area.
 - b. There is one school in the area: Lafayette Elementary School.
 - c. Lafayette Recreation Center is in the area which generate pedestrian and bicycle activity.
 - d. There are multiple bus stops in the area which generate pedestrian activity.
 - e. There is on-street parking on both sides of all four legs of the intersection.

Although the speed data analysis showed travel speeds being lower than or equal to the posted speed limit, at this location, there is still a safety concern at this location. The proposed location is nearby Lafayette Elementary School and Lafayette Recreation Center, both of which generate not only pedestrian and bicycle activity, but children as pedestrian generators. Thus, because of the nearness of the site to a school zone, and the specific site characteristics of a residential area, there is a nexus between traffic safety and the speed camera at this location
